



# **Assetinsure Surety Bonds / Contract Performance Bonds Information Sheet**

Bank Guarantees vs. Surety Bonds backed by Swiss Re









### 1. Type of Document:

- Both are unconditional and irrevocable undertakings issued by a Bank or Swiss Re International SE;
- Both are payable on demand and have the same wording and legal obligations;
- Common names for a Contract Performance Bond include: Bond, Surety Bond, Insurance Bond, Unconditional Undertaking, Bank Guarantee (if issued by a Bank).

#### 2. Strength of Document:

- Bank Guarantees are backed by the financial strength of the Bank issuing the document;
- Swiss Re Bonds are backed by the financial strength of Swiss Re International SE, a wholly owned subsidiary of the Swiss Re Group, the second largest reinsurer and Contract Performance Bond provider in the world with Market Capitalisation of A\$43.9 billion;
- Assetinsure easily satisfies the minimum criteria for acceptance by NZ Ministry of Education and NZ Transport Agency;
- Swiss Re International SE has the same Standard & Poor's credit rating as that of the 4 major Australian banks, being AA-, with a superior outlook of Stable. No other financial institution in Australia has a higher credit rating (refer attached Ratings Table);
- This makes Swiss Re Bonds "as good as" cash;
- Swiss Re Bonds are widely accepted by a large number of corporate entities and also government agencies at Federal, State and Local Authority level (refer attached Beneficiaries Extract) and meets the Treasury guidelines of all State Government Treasuries.

#### 3. Claims Process:

- Same process is undertaken for a Bank Guarantee and a Swiss Re Bond;
- Bonds can be presented locally for claiming;
- Following confirmation, the amount claimed is paid within 8 hours, usually into a nominated account or by cheque. As an unconditional undertaking, it is stressed that there is no requirement to prove that there has been a lack of performance or any further justification for making the claim;
- Bonds are not subject to an "insurance style claims process", as they are not an insurance product.

#### 4. Common Misconceptions:

- "A Swiss Re Bond is an insurance policy";
- "A Swiss Re Bond doesn't have the same obligations as a bond issued by a bank";
- "Insurance companies aren't as secure as banks";
- "It's more difficult to make a claim on a Swiss Re International SE Bond".
